**IMPORTANT NOTICE:** By signing this agreement you are giving up certain legal rights, including the right to recover damages in case of injury, death, or property damage, arising out of your riding or use of the owners horse and/or participation in equine activities or ranch activities at Clermont Equestrian, including injury, death, or property damage arising out of the negligence of you or Manon Cremer Ceja, Robert Ceja or Clermont Equestrian.

Read this agreement carefully before signing it. Your signature indicates your understanding of and agreement to its terms. By signing this form, I hereby acknowledge on behalf of myself that I have familiarized myself with the activities that I will be allowed to participate in, and that I do hereby acknowledge and agree that I will participate in these activities without restriction or limitation. I recognize the inherent risks involved in riding and working with or around horses, including but not limited to:

Bites, kicks, abrasions or contusions from horses or any other animals on property. Being thrown or falling off horses. Allergic reactions to animals, hay, or other allergens. Tripping in holes or on materials or equipment.

Scratches or other injury from stalls, enclosures including electric tape, grooming tools, tack and other equine equipment.

Scratches or other injury from ranch equipment such as but not limited to mower, drag, tools, tractor, utvs and vehicles.

Thereby specifically forever waive and release Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian and its principals and agents from any liability for injury arising out of the inherent risks from riding, working or participating in a stable environment and/or with horses, as well as from the active negligence of Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian, its principals and agents.

By signing this agreement I hereby acknowledge that although there may be supervision during my time spent at Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian, there will not be any medical personals on the premises and Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian and its principals and agents bear no responsibility for my health or medical care. I agree to indemnify, save and hold harmless Manon Cremer Ceia, Robert Ceia OR Clermont Equestrian and its principals and agents from and against any loss, liability, damage, attorneys' fees, or costs that they may incur arising out of or in any way connected with either my presence or participation at Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian or any acts or omissions of Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian principals or agents.

By signing this agreement, I hereby acknowledge my complete understanding, agreement and consent to my presence and/or participation in the activities at Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian, without restriction, without liability to Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian, its principals or agents, and with full knowledge and understanding of the disclosures, waivers, and releases herein. If I am present at and participate in the activities of Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian I do so at my own risk, and I hereby acknowledge and agree that Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian and/or any of its principals and agents shall bear no responsibility or risk associated with injuries that could arise from my presence or participation at Manon Cremer Ceja, Robert Ceja OR Clermont Equestrian.
